We are seeking a Graphic Artist to illustrate an environmental 'systems map' diagrammatic spread for the Hudson River Watershed Surface Drinking Water Climate Vulnerability Matrix. The graphics need to demonstrate the connectivity of the hydrologic system to enable community and drinking water system operators to better understand potential climate change impacts to surface drinking water. The deliverables will require 2 digital spreads for Hudson River Watershed surface graphic drinking. Assignment will run from April 22 – May 30, 2024.
